37. THE 2016 CITY CENTRE PUBLIC SPACE PROTECTION ORDER (AND OTHERS) (VARIATIONS AND EXTENSIONS AND DISCHARGES)

Previous reference: Minute 18 (2019-20)

The Assistant Director, Neighbourhoods and Customer Services presented **Document "M"** which provided a summary of the responses from the statutory consultation on the proposed extension, variation or discharge of the Public Space Protection Orders (PSPOs) for Bradford City Centre, Keighley Town Centre, Shipley Town Centre, Bingley Town Centre and West Bowling and submission of proposals arising from the responses to the consultations.

He reminded Members that at its meeting on 18 July 2019, the Committee authorised the undertaking of a public consultation. 71 responses had been received in response to an online survey as well as written support for the continuation of the PSPO from the Police and Crime Commissioner for West Yorkshire, Bradford District Chamber of Trade and Bradford Business Improvement District (BID).

He stated that since the introduction of the City Centre PSPO (relating to legal highs and alcohol misuse) in October 2016 the number of alcohol related incidents recorded by the Police had fallen by 43% district-wide and 54% in the city centre. He recommended that, with the exception of the PSPO for West Bowling where there was no evidence base to continue, the current PSPOs be extended for a further three years.

In response to a question from the Chair, it was reported that there was lack of evidence of continuing levels of antisocial behaviour to justify the continuation of the PSPO in West Bowling and that it was introduced due to issues arising from a particular premises, which had since closed and incidents had significantly reduced as a consequence.

The City Solicitor provided assurances to Members that he considered there was sufficient evidence on which to make their decision and, if they were minded to approve the continuation of the PSPOs, suggested they be listed in the resolution.

Resolved –

(1) That the Assistant Director, Neighbourhoods be authorised to:

(i) extend the current Public Space Protection Orders listed in (i) to (vi) below for three years in Bradford City Centre, Shipley Town Centre, Bingley Town Centre and Keighley Town Centre and replace the words 'exclusions zone' with restricted area in the 2016 City Centre order:

(i) Public Space Protection Order 1 of 2016

(ii) Drinking in Public Places Designated Order No 2 Areas within Bingley Town Centre 2003 PSPO

(iii) Drinking in Public Places Designated Order No 3 Areas within Shipley Town Centre 2003 PSPO

- (iv) **Drinking in Public Places Designation Order No 4 Areas within Keighley Town Centre 2003 PSPO**
 - (v) **Drinking in Public Places Designation Order No 1 Areas within Bradford City Centre 2002 PSPO**
 - (vi) **Drinking in Public Places Designation Order No 1 Extension of Areas within Bradford City Centre 2003 PSPO**
- (ii) **and remove the restrictions relating to 'legal highs' in the 2016 order due to lack of evidence to justify the continuation of that restriction in the order and create a new order dated 2019.**
- (2) **That the Public Space Protection Order for West Bowling be discharged due to lack of response from the consultation and lack of evidence of continuing levels of antisocial behaviour to justify the continuation of the order, as detailed in Appendix F to Document "M".**

THE LOCAL AUTHORITIES (ALCOHOL CONSUMPTION IN DESIGNATED
PUBLIC PLACES) REGULATIONS 2001**

**DRINKING IN PUBLIC PLACES DESIGNATION ORDER N04 AREAS
WITHIN KEIGHLEY TOWN CENTRE**

The City of Bradford Metropolitan District Council (in this Order called "the Council") makes the following Order:-

1. The land described in the Schedule below and shown outlined in blue on the plan attached to this Order, being a public place in the area of the Council to which the provisions of Sections 12 to 16 of the Criminal Justice and Police Act 2001 apply, is hereby designated for the purposes of that Act.
2. The effect of this Order is to make it an offence if any person fails, without reasonable excuse, to comply with a constable's requirements:-
 - (a) not to consume in that place anything which is, or which the constable reasonably believes to be, alcohol;
 - (b) to surrender anything in the possession of that person which is or which the constable reasonably believes to be, alcohol or a container for alcohol.

A constable who imposes a requirement on a person shall inform the person concerned that failing without reasonable excuse to comply with the requirement is an offence.

The maximum penalty upon conviction for any offence is £500.00 (level 2 on the standard scale).

3. This order may be cited as the City of Bradford Metropolitan District Council Drinking in Designated Public Places Order No. 4 Areas Within Keighley Town Centre and shall come into effect on 10th November 2003.

SCHEDULE
Land Designated by Description

An area of land in Keighley bounded by (and including): Mornington Street, North Street (from Mornington Street, Alice Street, Lawkholme Lane (until Bradford Street), Bradford Street, Bradford Road (from Bradford Street), Dalton Lane (until Brewery Street), Brewery Street, Across Railway Tracks to Low Mill Lane (opposite Laneway running from Gresley Road), Laneway from Gresley Road towards Low Mill Lane, Gresley Road (from Laneway), East Parade, into Worth Way, South Street (from Worth Way), into Bridge Street, Damside, Oakworth Road (from Damside), Suresnes Road, Devonshire Street (to Belgrave Road), and Belgrave Road (until Mornington Street) and which also includes Barlow Road (south of Mornington Street), Lark Street, Raven Street, Rosemount Close, Rosemount Walk, Highfield Lane (east of Belgrave Road), Well Street, Bath Street, Nares Street, Redcliffe Street, Endfield Street (east of Belgrave Road), Argyle Street (east of Belgrave Road), Granville Street, Spencer Street (east of Belgrave Road), Eagle Street, Back Broomfield Road, Broomfield Road, Broomfield Street, Back Broomfield Street, Broomfield Place, Wilkin Street, Highfield Street, Albert Street, Kendal Mellor Court, Scott Street, Samuel Street, Campbell Street, Russell Street, Chapel Lane, Roper Street, Rectory Row, Temple Street, Temple Row, Quebec Street, High Street, Church Street, Smitherds Street, Marley Street, Waddington Street, Browsholme Street, Heber Street, Alkincote Street, Beck Street, Sun Street, Beck Side, Water Lane, Church Way, Market Street, Market Place, Low Street, Cooke Lane, Airedale Centre, Brunswick Arcade, College Walk, Queensway, Bank Street, Hanover Street, Carr Street, Hard Ings Road, Kingfisher Court, Cameronian Court, Fleece Street, Bow Street, Town Hall Street, Cooke Street, Lawkholme Crescent, Town Gate, Richardson Street, Cavendish Street, Lord Street, Henry Street, Fair Isle Court, North Queen Street, Bertha Street, Shed Street, Drill Street, Back Cavendish Street, Pond Street, Old Dalton Lane, Station Bridge, Low Mill Lane (from Lane to Gresley Road to East Parade), Keighley Station, Station Platform and Station Forecourt. 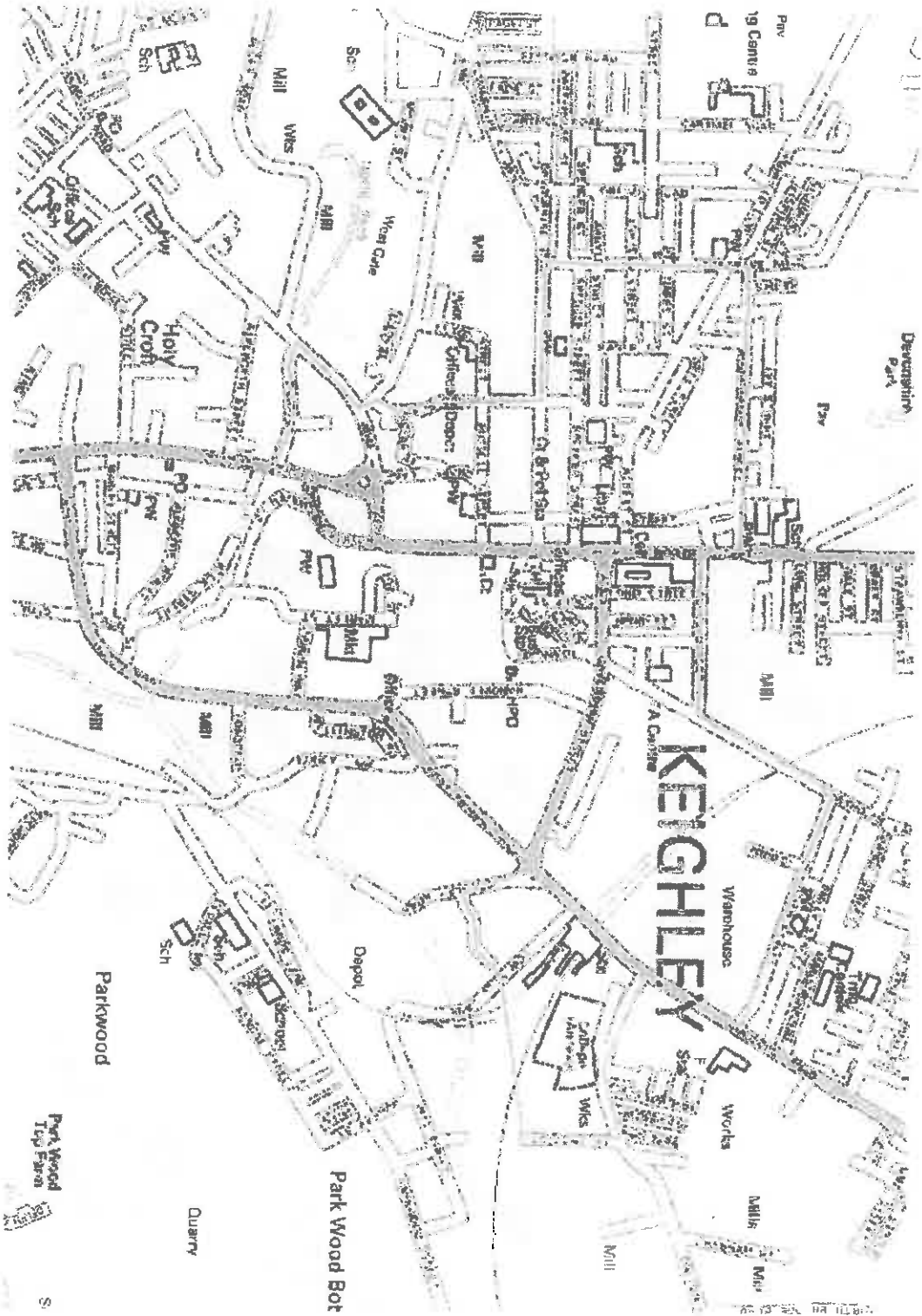
