**THE CITY OF BRADFORD METROPOLITAN DISTRICT COUNCIL PUBLIC SPACE PROTECTION ORDER (CONTROL OF ACTIVITIES THAT MAY CAUSE FIRES / WILDFIRES) NO 2/2019**

This Order is made by CITY OF BRADFORD METROPOLITAN DISTRICT COUNCIL (“the Council”)

Under the Anti-Social Behaviour, Crime and Policing Act 2014, Section 59 (“the Act”).

1. This Order relates to the public places described in the Schedule below, and defined by the area edged red on the plan attached to this Order (“the Restricted Area”

2. The Council is satisfied that the two conditions below have been met, in that:

(a) Activities carried on in the Restricted Area (with the exception of private property and legitimate land management practices on private land) as described below, have had a detrimental effect on the quality of life of those in the locality, or it is likely that these activities will be carried on in the public place and that they will have such an effect, the said activities being the lighting of fires; barbecues; Chinese lanterns, fireworks or any article/object which causes a naked flame.

(b) The effect, or likely effect, of the activities described above

(i) is, or is likely to be, of a persistent or continuing nature,

(ii) is, or is likely to be, such as to make the activities unreasonable,

and

(iii) justifies the restrictions imposed by this Order.

3. The effect of this Order is to impose the following prohibitions from midnight 30<sup>th</sup> June 2019 until midnight the 30th June 2022 namely that within the Restricted Area (as defined by the map attached, a person or persons are prohibited from the following activities:

(i) the lighting of fires; barbecues; Chinese lanterns; fireworks

(ii) or using any article/object which causes a naked flame and which poses a risk of fire.

b. The effect of this Order is to impose the following requirements from 1st July 2019 until 30<sup>th</sup> June 2022 namely that within the Restricted Area (as defined by the map attached)

person or persons are required to extinguish and surrender anything in their possession which a constable or authorised person has reasonable suspicion to be an article that has been used OR is likely to be used in conjunction with the prohibited activities referred to in this Order.

4.

Any person who fails without reasonable excuse to comply with a requirement imposed on him by this Order or does anything that he is prohibited from doing by this Order commits an offence and is liable on summary conviction to a fine not exceeding level 3 on the standard scale or may be issued with a fixed penalty notice requiring payment of a sum not exceeding £100.

5.

This Order will remain in force for a period of 3 years unless extended by further Orders under the Council's statutory powers.

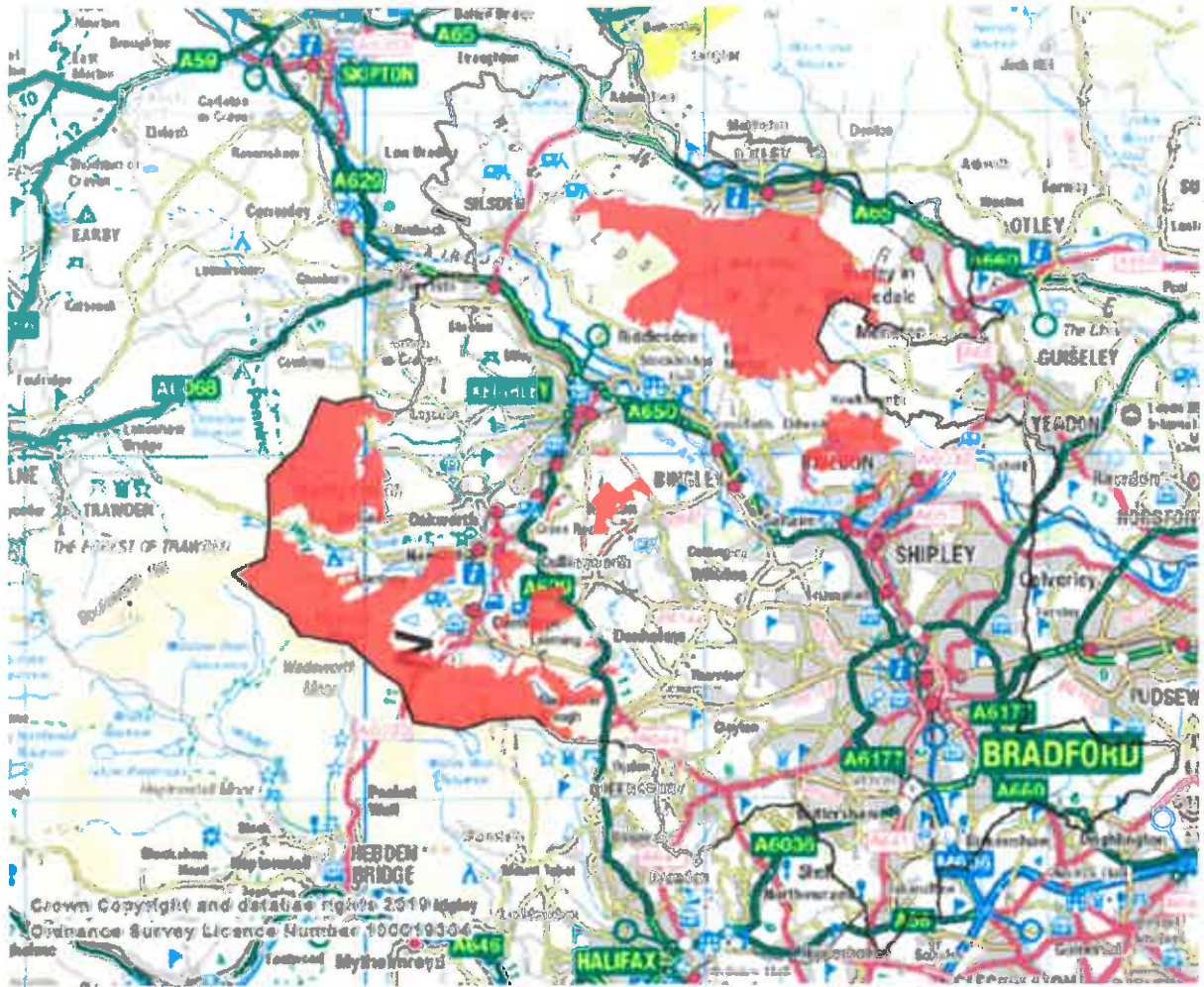
